Dr. Hemberg, PhD, will talk to us about his project, STEALTH (Simulating Tax Evasion And Law Through Heuristics). As described on the Computer Science and Artificial Inteligence Laboratory (CSAIL) ALFA Group's website (<a href="https://alfagroup.csail.mit.edu">https://alfagroup.csail.mit.edu</a>) "The project's goal is to develop technology that enables the discovery of non-compliant partnership transaction patterns. Through the use of partnerships and other "flow-through entities", taxpayers underreported more than \$91 billion of income annually between 2006 and 2009 (GAO-14-453), and the trend shows little sign of stopping."

Who will use this research? Will it be the legislators? Can the research be transferred into technology? How will STEALTH "learn"? Can STEALTH detect avoidance of tax law? Can STEALTH learn from past tax returns and the dispositions made about them? The project targets partnerships and other flow-through entities; why them? Are there other compliance-monitoring, Al applications in use today? Contemplated? What makes STEALTH different from, say, insurance company fraud detection applications or credit card bogus transaction detection applications? Erik will help us understand these and other questions.
